From Route 128/95

Take Exit 27A (Totton Pond Road). At the end of the ramp take a right onto Totton Pond Road. Go to the end of the road, approximately 1.7 miles (traffic light at intersection). Take a left onto Lexington Street. The Espousal Center is .3 miles on the left. Blue sign is at the end of the driveway that reads Stigmatine Fathers.

From the Mass Pike (Rt. 90) and from Rt. 9

Take 128 North and follow directions above.

From Route 2

Take 128 South and follow directions above.

From Route 20 and From the East

Follow Rt. 20 (Main Street) into Waltham.

At the first light after Post Office, turn right onto Bacon Street. Follow Bacon Street until it intersects with Lexington Street. Proceed on Lexington Street for .3 miles to the Espousal Center, Blue sign is at the end of the driveway that reads Stigmatine Fathers.

From the West

Follow Weston Street to main Street. At first traffic light after Victory Supermarket, turn left onto Bacon Street. Follow Bacon Street until it intersects with Lexington Street. Proceed on Lexington Street for .3 miles to the Espousal Center, Blue sign is at the end of the driveway that reads Stigmatine Fathers.

- Mass Turnpike (I90) to Exit 11A
- South on Interstate 495 to Exit 19 (Route 109)
- Right off the exit ramp onto Route 109 West
- **** Travel approximately 1/2 mile to traffic light and turn left onto Birch Street (Maria's Italian Villa will be on your left). Follow Birch Street to the end and turn right onto Maple Street. Bear left at the fork in the road. Travel approximately 1/4 mile to the Waters Corporation main entrance on the left. Visitor parking is available.

From the South

- Interstate 95 North to Interstate 495 North
- Take Interstate 495 to Exit 19, Route 109 West.
- Left at light at bottom of the exit ramp onto Route 109 West
